Context

Please find below a list of external companies that we share your data with- the second column identifies the type of data we share and the purpose of this. The majority of data shared with other companies is pupil name only (i.e. not address, photographs or other identifiable information) and is stored within Europe. We do not share information with any company for purposes of marketing.

Company	What data is shared & purposes
2 Simple	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
Active Learn Primary	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
Bristol City Council	Information shared with BCC as part of statutory role and monitoring.
Bug Club	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
Capita SIMS	SIMS is the management system used by WTLA to store all pupil information.
CareMonkey	Email or telephone details shared, but information then populated by parents therefore they control what information is provided (school cannot edit the data). The app is used for storing medical information and coordinating trips, visits and sporting activities.
CPOMS	This is a web based Child Protection tracking system to ensure we comply with relevant legislation, noting concerns and actions.
Facebook	Data in form of photographs is shared on Facebook- older page contains historical photos with permission obtained from parents/ carers- new page closed. Photo permission is obtained.
IRIS	This is a teacher video system for staff to video their own lessons and reflect on their practice. Children are not identified and no personal data is

	shared. This is not open to the public.
Libacura	Some information is stored on this system for children attending wrap around provision.
Microsoft	Basic details such as pupil numbers in each yeargroup is shared with Microsoft for the purposes of licensing.
Nessy Learning	This computer system is used to support children with additional needs, where names are provided to generate access and track progress.
ParentPay	Parent information is shared with ParentPay for the purposes of providing an online payment method for school activities. Parents/ carers have control over the personal financial information to the site, with school not having access to this.
Pearson Ed	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
Reading Cloud	This is our library system where pupil names are logged on the system to record books and track reading.
SchoolComms	Information is shared with SchoolComms to provide an email and texting service for emergency use.
Scratch	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
S Glos Council	Our HR and Payroll functions are managed by S Glos Council, therefore they have access to school systems. They do not require pupil level data.
Tapestry	We track progress of children within EYFS using Tapestry, a web based app with parental access.
Target Tracker	We track progress of children using Target Tracker (managed by Essex County Council) in order to provide attainment and progress data to school.
TT Rockstars	Names provided to generate usernames & passwords- app based programs to support curriculum learning.
